Burdette), shows W.H. while living in Oconee Co.,SC with his daughter Elizabeth(aged 62) that his father was born in Germany and mother in SC.... This can then be assumed that all Group 4 members are of the GERMAN Burditt/Burdett lineage. More than likely the name (or spelling of) was changed to a more English version upon arrival to SC by the father of William H.
